VOLUNTEER PROCEDURES

Recruitment and selection of volunteers is done at the local building level. Interested individuals should contact the building principal or his/her designee. The interests and abilities of volunteers should be considered when making assignments. Any volunteer who will have unsupervised access to students must complete a background screening that is absent any of the misconducts that would prohibit a person from being employed in the district. Volunteers cannot have unsupervised access to students until the criminal record check is done.

People interested in volunteering for a duty which they will have unsupervised access to students should complete the paper volunteer application form and submit it to the principal in the building they wish to volunteer as well as submit a volunteer application online at the following site:

If the principal approves the volunteer paper application he/she will sign the application form and forward it onto Kris Thompson at the Board of Education Office to approve the processing of the applicant's online application.

Once the screening is complete the application will be reviewed and the principal will be notified of the results, either approved or not approved. If approved the volunteer will receive in the mail an ID tag stating that they are approved as a volunteer, if not approved the applicant will receive notice explaining their rights via the US Postal Service.

All volunteers should have this Volunteer ID with them at all times they are volunteering in the district.

The principal is authorized with the approval of the Superintendent or the Superintendent is authorized on a district wide basis to decline the services of any school volunteer because of a criminal conviction or based upon prior serious conflict between a potential school volunteer and school officials, employees, students, parents of students or existing school volunteers which may tend to create tension in the building or presents the potential of disrupting school activities.
