RESOLUTION 13-078

RENEWAL TAX OF 1.10 MILLS FOR PERMANENT IMPROVEMENTS FOR FIVE YEARS

The adoption of the following resolution was moved by Mr. Heffner and seconded by Mrs. Reives:

Resolution Declaring It Necessary To Levy A Renewal Tax And Requesting The County Auditor To Certify Matters In Connection With A Proposed Tax Levy

"Be it by the Board of Education of the Troy City School District (herein the "School District").

SECTION 1. That it is hereby declared that the amount of taxes which may be raised in this School District within the ten-mill limitation by levies on the current tax duplicate will be insufficient to provide an adequate amount for the necessary requirements of this School District.

SECTION 2. That pursuant to the provisions of Section 5705.21 of the Ohio Revised Code, it is necessary that a renewal tax be levied in excess of the ten-mill limitation for the benefit of this School District, for the purpose of general permanent improvements at a rate not exceeding one and one-tenth (1.10) mills for each one dollar (\$1.00) of valuation for a period of five (5) years. Said tax is proposed to renew an existing one and one-tenth (1.10) mills, five (5) year levy authorized by a majority of the electors of the school district voting on said proposition at an election held on May 5, 2009.

SECTION 3. That the question of the adoption of said renewal tax levy shall be submitted to the electors of the school district at the election to be held on November 5, 2013. If approved by the electors, said renewal tax levy shall first be placed upon the 2014 tax list and duplicate, for first collection in calendar year 2015.

SECTION 4. That pursuant to Section 5705.03 of the Ohio Revised Code, the county auditor is hereby requested to certify to this board of education the total current tax valuation of this school district and the dollar amount of revenue that would be generated by the number of mills specified in Section 2 hereof, and the treasurer of this board of education be and is hereby directed to certify forthwith a copy of this resolution to the county auditor as required by law so that said county auditor may certify such matters in accordance with Section 5705.03 of the Ohio Revised Code.

SECTION 5. It is found and determined that all formal actions of this board of education concerning and relating to the adoption of this resolution were adopted in an open meeting of this board of education, and that all deliberations of this board of education, and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the rules of this board of education adopted in accordance therewith."

A RESOLUTION OF THE BOARD OF EDUCATION OF THE TROY CITY SCHOOL DISTRICT AMENDING POLICY KG-R, RULES AND REGULATIONS GOVERNING THE USE OF SCHOOL BUILDINGS, FACILITIES AND GROUNDS,BY ALLOWING THE POSSESSION OR USE OF ALCOHOLIC BEVERAGES IN A LIMITED AND CONTROLLED MANNER AT SIGNIFICANT COMMUNITY EVENTS

The adoption of the following resolution was moved by Mr. Lucas and seconded by Mr. Lutz:

"Whereas, the possession or use of alcoholic beverages on school property is presently prohibited by Rule 10 of the Rules and Regulations Governing the Use of School Buildings, Facilities and Grounds (Policy KG-R), and

Whereas, Troy Main Street, Inc. and the City of Troy have requested a limited modification of this policy in the interest of promoting significant community events.

Be it resolved:

1. That Rule 10 of the Rules and Regulations Governing the Use of School Buildings, Facilities and Grounds (Policy KG-R) is hereby amended to add the following:

That notwithstanding the foregoing policy, this Board may by resolution make an exception to the prohibition of the possession or use of alcoholic beverages on school property upon the written request from the sponsor of a community event, which meets all of the following criteria:

- A. The community event for which the waiver is sought will provide a significant economic benefit to the Troy community.
- B. A written proposal is presented to the Board which addresses in detail the means and manner in which the possession and use of alcoholic beverages on school property will be monitored and controlled.
- C. The sponsor of the event provides assurances which are satisfactory to this Board that allowing the possession and use of alcoholic beverages on school property will not adversely affect the overall educational mission of this school district."
