The Board of Education of the Troy City School District met in regular session at the Troy Board of Education Office, 500 N. Market St., Troy, Ohio 45373, at 5:30 P.M. on Monday, January 13, 2020 for the purpose of organizing itself for calendar year 2020; by electing a president and a vice president for 2020; by fixing, subject to change, the time, date, and place of regular meetings of the Board of Education during 2020; and by appointing its members to various councils, committees, boards, assemblies, and like bodies during 2020. The President Pro-Tempore of the Board of Education, Mr. Kleptz, presided. Following the Pledge of Allegiance, Mr. Price, Treasurer called the roll and the following members of the Board of Education were present: Mrs. Beamish, Mrs. Borchers, Mr. Ham, Mr. Kleptz and Mr. Doug Trostle. Also in attendance were several administrators and visitors.

RESOLUTION 20-001

ELECTION OF PRESIDENT FOR 2020

Mr. Kleptz called for nominations for President of the Board of Education for 2020. Mrs. Borchers nominated Mr. Kleptz and Mr. Ham seconded the motion. Mr. Kleptz called for other nominations and hearing none, nominations were closed. The roll then was called on the question of who should be President of the Board of Education in 2020, and the following vote resulted: Mrs. Beamish, Mrs. Borchers, Mr. Ham, Mr. Kleptz and Mr. Trostle voted in favor of Mr. Kleptz's nomination.

RESOLUTION 20-008

RESOLUTION EXPRESSING INTENT TO USE CONSTRUCTION MANAGER AT RISK PROJECT DELIVERY METHOD FOR CONSTRUCTION OF SCHOOL IMPROVEMENTS

The adoption of the following resolution was moved by Mr. Trostle and seconded by Mr. Ham:

Attached hereto and incorporated herein by reference as Exhibit F is the Legal Notice CMR RFQ and as Exhibit G is the Request for Qualifications. These exhibits are supporting documentation to the resolution below.

The Superintendent recommends using the construction manager at risk project delivery method for construction of school improvements included in the ELPP project, which will address District needs.

Rationale:

- 1. After reviewing the construction project delivery method options available to Ohio public school districts, the Superintendent recommends the construction manager at risk delivery method as the best approach for the planned school improvements that will result in District improvements designed and constructed as an Expedited Local Partnership Program (ELPP) project, with other improvements outside the scope of the ELPP project (all of which is referred to as the ELPP Project).
- 2. The construction manager at risk project delivery method provides an opportunity to involve the construction manager at risk firm (CMR) in the design of improvements, to then negotiate a guaranteed maximum price with the CMR for the work, and to approve the use of pre-qualified subcontractors by the CMR for the work, all of which is an open-book approach to pricing the work.
- 3. Selecting a CMR is subject to specific requirements outlined in the Ohio Revised Code and Ohio Administrative Code.

The Troy City School District Board of Education resolves as follows:

- 1. The Board expresses its intent to use the construction manager at risk project delivery method for the planned school improvements, which will be funded with proceeds from a bond issue placed initially on the March 17, 2020 ballot.
- 2. The Superintendent and Treasurer are authorized to work with legal counsel to conduct the required process and to bring a recommendation to the Board as to the best value CMR firm for the ELPP Project.

3. The Board authorizes by the Superintendent and Treasurer to start the selection process required by the Ohio Revised Code and Ohio Administrative Code for Ohio public entities, including preparing and placing a legal notice to solicit qualifications from firms interested in being the CMR for the ELPP Project and issuing an RFQ as required for the first phase of the selection process, in order to short-list a minimum of three qualified firms to receive an RFP for pricing and technical proposals that will serve as the basis for determining the best value firm for the ELPP Project.

A RESOLUTION DECLARING THAT THE BOARD OF EDUCATION OF THE TROY CITY SCHOOL DISTRICT HAS REVIEWED THE DOCUMENTS AND INFORMATION PREPARED BY THE CHIEF FISCAL OFFICER OF THE TROY CITY SCHOOLS FOR SUBMISSION TO THE BUDGET COMMISSION OF MIAMI COUNTY, OHIO, IN RELATION TO THE ALTERNATIVE TAX DOCUMENT FORMAT FILING PROVIDED UNDER SECTION 5705.281 OF THE OHIO REVISED CODE AND AUTHORIZED BY SAID COMMISSION FOR THE FISCAL YEAR 2021, AND THAT SAID BODY APPROVES EXHIBIT H.

The adoption of the following resolution was moved by Mrs. Borchers and seconded by Mrs. Beamish:

WHEREAS, Section 5705.281 of the Ohio Revised Code authorizes and empowers a county budget commission, by an affirmative vote of a majority of its members, including an affirmative vote by the auditor of the county, to waive the requirement that a taxing authority of a subdivision or other taxing unit adopt a tax budget, as is provided under Section 5705.28 of the Ohio Revised Code, and require such taxing authority to provide such information as may be required by the commission to perform its duties under Chapter 5705 of the Ohio Revised Code, including dividing the rates of each of the subdivision's or taxing unit's tax levies as provided under Section 5705.04 of the Ohio Revised Code; and

WHEREAS, pursuant to the terms and provisions of Section 5705.281 of the Ohio Revised Code, the Miami County Budget Commission, by an affirmative vote of a majority of its members, including an affirmative vote by the Auditor of Miami County, Ohio, has authorized and permits the taxing authority of a subdivision or other taxing unit within Miami County, Ohio, to refrain from adopting a tax budget, and has designated the information which the said Budget Commission requires of each taxing authority of a subdivision or other taxing unit to permit the Budget Commission to perform its duties under Chapter 5705 of the Ohio Revised Code; and

WHEREAS, it is the desire and intention of The Troy Board of Education, as the taxing authority of The Troy City School District, to elect to refrain from adopting a tax budget for the fiscal year 2021, and, in the alternative, to submit to the Budget Commission the information and documents which it has indicated will be necessary in the absence of such adoption; and

WHEREAS, previously by its enactment of Resolution No. 19-121 the Board of Education of the Troy City Schools declared its said desire and intention, and authorized and directed the Chief Fiscal Officer of the Troy City Schools to prepare and to submit to the Miami County Budget Commission such information and documents as are necessary incident to said process and submission, and to take such other actions as may be reasonably necessary incident thereto; and,

WHEREAS, the members of the Troy City Board of Education have examined such information and documents and approve Exhibit H;

Be it resolved by the Troy City School District Board of Education, Troy, Miami County, Ohio, that:

- 1. The Board of Education of the Troy City School District hereby declares that the members of said body have examined the contents of the information and documents which have been prepared by the Chief Fiscal Officer of the Troy City School District for submission to the Miami County Budget Commission under the alternative tax document format provided by Section 5705.281 of the Ohio Revised Code for the fiscal year 2021, and that the Board of Education of the Troy City School District hereby approves Exhibit H; and
- 2. The Board of Education of the Troy City School District hereby authorizes and directs the Chief Fiscal Officer of the Troy City School District to submit such information and documents to Miami County Budget Commission, and to take such other actions as may be reasonably necessary incident to said submission; and
- 3. The Board of Education of the Troy City School District hereby finds and determines that all deliberations and actions related to the foregoing were effected in open and public session and in full compliance with Section 121.22 of the Ohio Revised Code, and otherwise as is provided by law.
