RESOLUTION 18-075

RESOLUTION DECLARING IT NECESSARY TO LEVY A RENEWAL TAX AND REQUESTING THE COUNTY AUDITOR TO CERTIFY MATTERS IN CONNECTION WITH A PROPOSED TAX LEVY

The adoption of the following resolution was moved by Mrs. Beamish and seconded by Mr. Ham:

WHEREAS, the electors of the Troy City School District approved a one and one-tenth (1.1) mill levy at the November 5, 2013 election for a period of five (5) years, for the purpose of general permanent improvements; and

WHEREAS, the authority to levy that one and one-tenth (1.1) mill tax expires with the levy to be made on the 2018 tax list and duplicate for collection in calendar year 2019, and in order to provide for the collection of tax revenues for that purpose without interruption, this Board finds it necessary to renew the existing one and one-tenth (1.1) mill levy for five (5) years.

BE IT RESOLVED by the Board of Education of the Troy City School District (herein the "School District"), at least two-thirds of all members voting in the affirmative:

SECTION 1. That it is hereby declared that the amount of taxes which may be raised in this School District within the ten-mill limitation by levies on the current tax duplicate will be insufficient to provide an adequate amount for the necessary requirements of this School District.

SECTION 2. That pursuant to the provisions of Section 5705.21 of the Ohio Revised Code, it is necessary that a renewal tax be levied in excess of the ten-mill limitation on the entire territory of the School District for the benefit of this School District, for the purpose of general permanent improvements at a rate not exceeding one and one-tenth (1.1) mill for each one dollar (\$1.00) of valuation for a period of five (5) years.

SECTION 3. That the question of the adoption of said renewal tax levy shall be submitted to the electors of the entire territory of School District at the election to be held on November 6, 2018. If approved by the electors, said tax levy shall first be placed upon the 2019 tax list and duplicate, for first collection in calendar year 2020.

SECTION 4. That pursuant to Section 5705.03 of the Ohio Revised Code, the County Auditor is hereby requested to certify to this Board of Education the total current tax valuation of this School District and the dollar amount of revenue that would be generated by the number of mills specified in Section 2 hereof, and the Treasurer of this Board of Education be and is hereby directed to certify forthwith a copy of this resolution to the County Auditor so that said County Auditor may certify such matters in accordance with Section 5705.03 of the Ohio Revised Code.

SECTION 5. It is found and determined that all formal actions of this Board of Education concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board of Education, and that all deliberations of this Board of Education, and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the rules of this Board of Education adopted in accordance therewith.

LINCOLN CENTER PROPERTY

The adoption of the following resolution was moved by Mr. Overla and seconded by Mr. Ham:

WHEREAS, the Board owns real property located at Lincoln Street and 110 Ash Street in Troy, Ohio and identified on the records of the Miami County Auditor as Parcel # D08-250110 and Parcel # D08-250115 (hereafter "the Property"); and

WHEREAS Parcel # D08-250115 is improved with a building commonly known as the Lincoln Community Center and which improvement is leased to the Park Commission of the City of Troy, Ohio; and

WHEREAS, as a result of the lease to the Park Commission of the City of Troy, Ohio, the Lincoln Community Center building is encumbered by a ninety-nine (99) year lease with an option to extend the lease for successive ninety-nine (99) year periods;

WHEREAS, the Board does not have the ability to utilize the Lincoln Community Center building as a result of the ninety-nine (99) year lease(s) in place;

WHEREAS, Parcel #D08-250110, which contains vacant land, was transferred to the Board by the Board of Park Commissioners of the City of Troy, Ohio in February 2017 and the Board does not have a use for this land and does not wish to incur the cost to maintain the land.

NOW, THEREFORE, BE IT RESOLVED that the Troy City School District Board of Education authorizes and approves the sale of all of its interest in the Property to the City of Troy, Ohio (hereafter "the City") via quit claim deed at a cost to the City of One Dollar (\$1.00).

BE IT FURTHER RESOLVED that as a result of the sale of the Property, the Board of Education terminates its lease dated August 18, 1938 with the Park Commission of the City of Tory, Ohio and any other lease agreements regarding the Board and the Property.

BE IT FURTHER RESOLVED that the Board President and Treasurer are authorized and directed to take the steps necessary to effectuate the aforesaid sale consistent with this resolution, including entering into any necessary agreement(s) with the City.
